#### **NATO SWEATER**

Will be issued to employees in specific roles both on board and ashore.

#### SHIRT/BLOUSE

The shirt should be worn with all buttons fastened when wearing a tie. The shirt/blouse should be tucked into the trousers/skirt. Short and long sleeve shirt/blouse are available. If wearing long sleeves they are not to be worn with the sleeves rolled up.

To ensure that we maintain safety at all times, employees working in food preparation and service areas are required to adhere to more stringent uniform procedure restrictions.

#### **PERSONAL HYGIENE**




